

**POWHATAN ARROW COACH:** Systems have been checked out and the car has left for some pre-excursion trips.

### In the News

611 RESTORATION UPDATE. Launched June 28, the "Fire Up 611!" campaign seeks \$3.5 million by Oct. 31 to make the ex-N&W #611 operational and to construct a shop on the museum's property where the engine can be housed and serviced. The goal is to have the #611 take part in NORFOLK SOUTHERN's 21st Century Steam passenger excursion program in 2014. "The money has not come in has quickly as we had hoped from the big donors, but it's coming in quickly from small donors," said museum Executive Director Bev Fitzpatrick. The museum had hoped by this time to have raised about \$750,000. "We're not there yet," he said. Museum officials have said the campaign began with \$150,000 already in hand. Rumors have it that NORFOLK SOUTHERN has optimistically delayed any scheduling of #611 on excursions until 2015. Previous reports that the #611 may be placed into running condition by the North Carolina Transportation Museum have been denied by some sources. VIRGINIA GOVERNOR SAYS PASSENGER RAIL IS COMING TO ROANOKE. Governor Bob McDonnell was recently in Roanoke, VA, for a signing ceremony where he announced that Roanoke, NORFOLK SOUTHERN, AMTRAK, and the Commonwealth have started to work together towards the goal of bringing passenger rail service back to Roanoke for the first time in more than 30 years. The Governor also stated that The General Assembly's transportation funding plan, pushed for by McDonnell last spring and now signed into law, will help provide the funding for rail line improvements and a passenger rail terminal. McDonnell mentioned a likely 3-4 year time frame before rail service might return; Virginia State Senator John Edwards (D-Roanoke), a long-time advocate, suggested 2-3 years as a timeline.

Wick Moorman, NORFOLK SOUTHERN CEO, said "We're proud to play a role today in starting a new chapter in the Star City's history." (Passenger trains will run on NS freight lines.) Thelma Drake, Director of the Department of Rail and Public Transportation for the State, noted that design work and rail capacity analysis between Roanoke and Lynchburg, where passengers would connect to AMTRAK, is already underway. "Virginia does not own a train nor do we operate train service. We use existing tracks and we rely on AMTRAK to operate Virginia passenger trains," noted Drake, a McDonnell appointee who was widely praised during the ceremony at Railside Plaza, with a NORFOLK SOUTHERN locomotive serving as a backdrop.

Lynchburg AMTRAK service, bolstered by additional trains in recent years, has turned out to be much more widely used than anticipated. Roanokers can now book AMTRAK and Smart Way Connector bus service to the Kemper Street Station in Lynchburg on a single ticket. Drake noted that Roanoke Mayor David Bowers "set his mind" on having passenger rail service return to Roanoke, "and never let up on that" even when initially there was no State funding available before a transportation funding plan was put in place this spring. #### NATIONAL GATEWAY COMPLETES PHASE ONE CLEARANCE [CSX Press Release]

The National Gateway coalition today announced the on-time, on-budget completion of its first phase, which clears the way for double-stack intermodal rail service between CSX's existing terminal in Chambersburg, Pa. and its state-of-the-art hub facility in Northwest Ohio.



The National Gateway, an award-winning \$850 million public private partnership to create a highly efficient and environmentally-friendly, double-stack cleared rail corridor between the Mid-Atlantic and Midwest, is made possible through a combination of federal and state funds and CSX investment.

"Today, we celebrate the efforts of federal and state officials in achieving this milestone, which means more jobs, a more competitive America, and a more environmentally friendly way to move freight," said Michael J. Ward, CSX chairman, president and chief executive officer.

"This is great news for our nation's transportation infrastructure, our customers and the communities we serve, and wouldn't be possible without the major investment of time and resources by our federal and state partners. While this is a significant milestone, our work is not done. Working with our public sector partners, we need to finish the job and complete doublestack clearances between Chambersburg and the Ports of Baltimore and Virginia."

Since its inception, the National Gateway generated support from governors and scores of public officials across six states, including more than three dozen members of Congress, three port authorities and dozens of global shippers, ocean carriers, business organizations and environmental groups.

Public funding for Phase One was supported by a federal TIGER (Transportation Investment Generating Economic Recovery) grant secured by the State of Ohio on behalf of the coalition, and administered by the Eastern Federal Lands Highway Division of the Federal Highway Administration.

As one of the nation's largest transportation projects, over a 30 year period, the National Gateway will create more than 50,000 jobs and deliver a host of benefits including reduced fuel consumption, lower emissions, better safety, lower highway maintenance costs and reduced shipping costs. The National Gateway is driving economic growth in areas like Wood County, Ohio, where the recently opened Northwest Ohio Intermodal Terminal employs nearly 300 full-time employees and is handling hundreds of thousands of containers per year.

"The National Gateway will stimulate economic activity and boost the United States' competitive edge in the global economy while employing the people who will prepare us to meet future challenges," added Ward. "CSX is proud to support this significant infrastructure investment that will help modernize our transportation system and spur growth."

The National Gateway is currently focused on the project's Phase Two, which will double-stack clear the CSX corridor between Chambersburg, Pa. and mid-Atlantic ports.

#### So You're Tired of Modeling in N or HO Scale?

Don Guill, a machine shop owner in the Cincinnati area, built a custom replica of #611. He displays it at special events. It has also appeared at the Virginia Transportation Museum. Don is semi-retiring, and is selling this model.

The engine and tender are 36' 5" long, 64" high, and 38" wide and it is 15" gauge. It weighs 16,000 pounds, and has a 135 HP Cummins diesel engine with a hydrostatic hydraulic drive. It also has a sound system, generates smoke, and a forward camera.

Moving it requires a trailer, and he is including that in the package.
