

### In the News ...

CLINCHFIELD #800

The January 2020 issue of TRAINS magazine offers two great shots of CRR F7 #800, the first ferrying ex-C&O 2-8-4 #2716 from its display at the Kentucky Railway Museum to the Kentucky Steam Heritage Corp. in Irvine, where it will undergo operational restoration. The #800 was on loan to KRM by its new owner, the Southern Appalachian Railway Museum in Knoxville. The second finds the #800 also on loan for excursion service offered by the Ohio Rail Experience.

### WY Plan to Sell Failed Intermodal Hub in Question

[Trains.com, 12/18/2019] CHARLESTON, W.Va. — The state may sell a failed West Virginia intermodal hub, built for \$32 million, for as little as \$1 million — a prospect that drew objections Tuesday from legislators.

The Heartland Intermodal Gateway in Prichard, W.Va., opened in December 2015 with the goal of handling 15,000 containers a year, the Charleston Gazette-Mail reports. It closed earlier this year after handling as few as 20 containers a month. Norfolk Southern stopped serving the 100-acre facility, built on land donated by the railroad, on Oct. 1.

The state is seeking bids from real estate auction companies to sell the facility, Transportation Secretary Byrd White said, but legislators asked that any auction be delayed until after the legislature returns in January.

State Sen. Robert Plymale argued during a Tuesday meeting of oversight committees on transportation and infrastructure that the facility "has been so mishandled by the [state Department of Transportation] and the Port Authority. ... I've never seen anything so mishandled." The Port Authority had not met for two years before a new member was appointed in July, Plymale said, to create a quorum for a meeting to authorize sale of the facility. Another legislator expressed concern that the state would get "mere pennies on the dollar for what was invested."

### MATRAK Service Expansion to Roanoke?

[WSLS TV 10, Roanoke via *Turntable Times*, Roanoke NRHS] Tourism leaders said AMTRAK is far exceeding expectations two years after passenger rail service returned to the Star City. AMTRAK representatives tell 10 News Roanoke's ridership is the highest of any individual line in the commonwealth. Since launching in 2017, that's more than 110,000 passengers coming in and out of Roanoke. "People that are curious. They're curious about a new way to travel and for us, that's great," said Brian Wells, general manager of the Hotel Roanoke. For the Hotel Roanoke, AMTRAK means big business. "We get a lot of guests that come off the train. Some of them are very impromptu. They were in Boston the day before and said, 'Hey, let's just get on the Northeast corridor and see where it takes us,'" Wells said.

Catherine Fox, vice president of public affairs and destination development for Visit Virginia's Blue Ridge, said AMTRAK's success benefits not only existing businesses, but future development. In just the last year, three new hotels have been announced in downtown, including one just this week. "Having AMTRAK has developed what we consider as a critical mass to downtown," Fox said. The early success is raising the question of whether AMTRAK could expand in Roanoke. "We'd love to see them expand to more than one daily train to northern Virginia and we'd love to see the timing of the train alter from early a.m. departure, late p.m. arrival to some additional train coverage in the middle of the day," Wells said. Jennifer Mitchell, director of the Virginia Department of Rail and Public Transportation, gave 10 News the following statement: "While there are no current expansions for the Roanoke line planned at this time, Virginia continues to work with our valued partners at Norfolk Southern to explore potential new mobility options for its citizens."

### See AMTRAK to Christiansburg and the New River Valley?

[Dorr Tucker, *Turntable Times*, Roanoke NRHS] Construction of a new passenger rail station in Christiansburg is well into the planning stage with a designated location that would be convenient for Blacksburg as well as other outlying New River Valley Communities.

Until recently, the thinking was to change the schedules of current southbound AMTRAK trains 171, 147 and 145 that are on slightly different schedules on different days of the week. That plan, using the same consist, was for the northbound trains to leave from the new Christiansburg station around 7:00 am weekdays (90 minutes later on weekends), receive passengers in Roanoke around 8:00 am, and head up to Alexandria and arriving at Union Station in Washington by 12:45 pm with a New York arrival around 5:30 pm and on to Boston before 11 pm. The southbound schedule would be essentially the same as 171 on weekdays but running about 30 minutes ahead of the present schedule to assure a pre-11 pm arrival at the new Christiansburg Station (at least on week days).

However, recent reports from notable authorities indicate that the Christiansburg service will be handled by separate trains with separate rolling stock. We understand that the northbound train will be scheduled to leave Christiansburg around 8:30 am on weekdays, but we don't have any knowledge of the southbound schedule but assume that it will run a little earlier in the day than either No. 147, 145, or weekday 171. Also, we don't have any knowledge of a New River Valley maintenance facility for the new service. Nor do we know if new crew districts will be established.

One area where we have a little knowledge is that the consists of the new trains must be backed 7 miles (that could be 6,5 miles from the new station location) to Walton to be turned on the Wye (unless some type of push/pull motive power is assigned). Walton is only about five miles from Radford where the former passenger station is a crew base and off limits to the general public; however, a short platform as well as a maintenance facility could be built.

We should note that passenger service to Christiansburg is still some time away, especially since Norfolk Southern has not yet agreed to do the study they require and funding from the Commonwealth is not yet available.
