### BLET Votes to Authorize National Strike

[trains.com, July 12, 2022] By a resounding margin, members of the Brotherhood of Locomotive Engineers and Trainmen have authorized a strike — a move that could come as soon as Monday, July 18. [ED. NOTE: it didn't; see below.]

The union — which represents more than 57,000 U.S. rail employees — reports 99.5% of its members voted to authorize a strike if such an action becomes legal and "necessary to secure a contract worthy of their consideration," BLET National President Dennis Pierce said in a statement issued Tuesday. It was the union's first nationwide strike vote since 2011.

Railroads "used and continue to use their economic strength to steamroll their employees, their customers and the nation, all for the sake of their bottom line, and it is clear that they have no intentions of changing," said Pierce, who also asserted that in the third year of the national contract negotiation process, "the rail carriers have never made a contract proposal to our union that their employees, our members, would accept."

Unions and railroads are currently in a 30-day cooling-off period mandated under the Railway Labor Act that began after the two sides failed to reach an agreement in talks before the National Mediation Board, and unions turned down an offer of binding arbitration.

The cooling off period ends July 18, at which point the union could legally strike — unless, before that date, President Joe Biden names a Presidential Emergency Board to investigate the dispute and make recommendations for a settlement. That would block a work stoppage for another 60 days — 30 days while the board investigates and makes its report, and 30 days after the report issued. [ED. NOTE: that occurred on July 15<sup>th</sup>.]

The National Railway Labor Conference, the association which includes the railroads' bargaining group, has said on its website that it expects such a board to be named, and business groups including the U.S. Chamber of Commerce have asked Biden to intervene. "It is imperative that the administration act to prevent any disruption to America's rail service," Chamber CEO Suzanne Clark said in a letter to Biden earlier this month.

### NS Trains Strikes Industrial Switcher

[trains.com] The Norfolk Southern train that derailed [July 11<sup>th</sup>] in Columbia, SC struck an already derailed industrial switcher on a track adjacent to its main line, according to NS. (continued)

The newspaper "The State" reports it was told by NS spokesman Connor Spielmaker that the locomotive — a yellow end-cab switcher visible in some photos of the accident — had been operating on a parallel track but derailed and "encroached on the Norfolk Southern train's right-of-way. ... We're still investigating what the [NS] train hit, but it was not another Norfolk Southern train."

Three locomotives and three articulated container well cars derailed following the collision about 8:20 a.m. Two crew members were injured; no update on their condition was available. The accident also led to a fuel spill that was contained by authorities.

## Update on New River Valley Passenger Service

[trains.com] The Virginia Passenger Rail Authority and Norfolk Southern have completed financing on the agreement which will expand passenger service to Roanoke, Va., and extend service southwest into the New River Valley.

The Western Rail Initiative Agreement sets the stage for the launch of a second daily Amtrak round trip between Roanoke and Washington, D.C., set to begin July 11<sup>th</sup>. It includes Virginia's purchase of 28 miles of right-of-way including existing track between Christiansburg and crossovers in Salem, VA, an easement between those crossovers and the Roanoke station; track and signal improvements between Manassas and the New River Valley, and a new station planned for Bedford, VA, as well as in the Christiansburg area. The \$257 million deal was originally announced in 2021.

"The closing of the Western Rail Agreement is great news for Virginians as this is a big step forward in our mission to expand passenger rail to the New River Valley," DJ Stadtler, executive director of the passenger authority, said in a press release, adding that "the improvements will also increase our economic opportunities by enhancing freight rail service through the Commonwealth."

Mike McClellan, Norfolk Southern senior vice president and chief strategy officer, said, "Together, we have reached an agreement that expands access for passengers and preserves an important link in the supply chain for businesses that rely on freight rail to ship base materials and finished products."

## N&W #611 Update

The Virginia Museum of Transportation is pleased to report that work on Norfolk & Western (N&W) 611 is progressing well. Per the Federal Railroad Administration regulations, we have completed the required five-year inspection. This work included removal of all jacket and insulation on the firebox, combustion chamber and cab, to allow access to the flexible staybolt caps.

Former N&W 611 has 2,537 flexible staybolt caps that all require removal, allowing access to the flexible staybolt to ensure that it is not broken. During this time, each staybolt sleeve, (where the staybolt is retained) is cleaned and inspected for any defective conditions. The inspection also included the threaded cap which is cleaned and reseated in the sleeve using a new copper gasket as a seal. This inspection cycle included machining all new caps from code material to allow for long term reliability during future inspections. The staybolt cap project was recently completed with final inspection being a successful test fire on June 14<sup>th</sup>, 2022, Flag Day. Scheduling for insulation and reassembly is currently being developed.

(Left) My wife and I took a little trip to Unicoi on a November afternoon last year to catch a southbound Q693, a manifest train, as it rumbled through the little community. As you may know my wife sits in the car and reads a book will I am out railfanning. She's a bookworm. On this day Q693 was being led by CSX 3413, a GE ET44AC unit. Q693 originates in Russell, KY and terminates in Rice Yard in Waycross, GA, working Kingsport yard and several more.

(Right) After watching and photographing Q693 in Unicoi, I jumped in the car and raced



south where I caught it as it was passing through Erwin behind the old Clinchfield office building. The trains seem to move very slow

through here as I have seen this happening several times.

coal train as it makes its way south down the main past C.P. NE Boone (MP Z111.1) probably heading to Duke Power. It is being led by CSX




7007 with a 2<sup>nd</sup> unit and a DPU mid-way back.



## Details of WVRHS&M Member Trip to TVRM



The Watauga Valley Railroad Museum is sponsoring a Summer Motor Coach trip to Tennessee Valley Railroad in Chattanooga TN on Saturday, August 20, 2022. The cost is \$80 per person which includes the motor coach trip along with all tickets at Tennessee Valley Railroad Museum and a tour of Chattanooga. The trip will include a luxury motor coach ride from Lowe's Parking lot in Jonesborough to the Tennessee Valley Railroad Museum in Chattanooga. On arrival at Chattanooga, we will board the Missionary Ridge Steam Excursion (either 4501 or 630) at Grand Junction Station; the steam excursion will take passengers over four bridges and through the pre-Civil War Missionary Ridge Tunnel. The trip is 60-65 minutes long and includes a turntable demonstration and tour of the TVRM restoration shop in East Chattanooga. Breakdown of the 6-miles round trip experience on the Missionary Ridge Local includes a tour guide providing local history throughout the experience.

You will also have a chance to visit the Tennessee Valley Railroad Museum exhibit building which includes the many passenger cars on the grounds, exhibit on the 2<sup>nd</sup> floor of the depot, and access to the new exhibit building on Turntable Drive. The special exhibits will be located in TVRM's new exhibit building and include "TVRM's First 60 Years," a Railroad Post Office car display, and two exhibits by sponsor Scale Trains. This is the first use for this important addition to the TVRM Cromwell Road Campus.

After we leave Tennessee Valley Railroad, we will go and have lunch then a drive-by tour of the famous NS Debutts Hump Yard. Next a visit to Chattanooga Choo Choo, then depart back home.
